1. Retirement of Mrs Rajni Bector as Director and her proposed appointment as Chairperson Emeritus

Mrs. Rajni Bector will retire from the Board of Directors of the company after a long association as the founder and will relinquish her position as member of the Board w.e.f. March 31, 2021. The Board also took note of her splendid contribution in the progress of the Company. Under her able guidance, the company has built national brands in biscuits and bakery segments.

She will continue to guide, mentor and support the Company to ensure continuous growth and expansion of business in future besides pursuing her philanthropic interest.
